Member's Acknowledgement

The assemblies of the Lord Jesus Christ (hereinafter called Organization) is an organization which was formed to assist ministers and churches in promulgating the Gospel of Jesus Christ to the world. Minister, and/or the churches they pastor, may become members of the Assemblies of the Lord Jesus Chris through the process which is outlined in its Constitution. The Organization does not hire ministers. The Organization does not own any churches. Article VII, Section I, paragraph 1, reads:

"Each church pastors by a minister of the Organization shall be sovereign within itself."

Each church is governed by its own pastor and church constitution. Problems which arise in any local church are addressed by the local church. The only time the Organization shall become involved in church affairs is when a local church invites the organization to assist in some manner; on such occasions, the Organization will only act in an advisory capacity.

The only time the Organization would be involved with a minister and his ministry would be when his actions conflict with the Constitution of the Organization, which he, when making application, agreed to abide by. The Organization's disciplinary and judicial procedure would then be invoked to address the problem.

The extent of the Organization's responsibility and involvement in any minister's conduct is according to Constitutional procedure, which does involve his membership in the Organization and his spiritual fitness for the ministry.

The Organization does not supervise, oversee, monitor, direct, or otherwise control any member or member church. This is a voluntary organization and is not a business relationship. The member does not have the authority to speak for, act for, or enter into transactions for or on behalf of the Organization. No partnership, joint venture, agency or other legal relationship is created by membership.

The member may not use the Organization's name without express written permission or as otherwise provided in the Constitution. The member may not promote the Organization as a supporter of or participant in any endeavor without express written permission.

Member agrees that the Organization is not responsible for or liable for any misconduct of the member, whether civil or criminal in nature, and holds the Organization harmless from any such liability. Member agrees to indemnify Organization for any such liability which is adjudged against the Organization and for the Organization's costs, expenses and attorney fees incurred as a result of such misconduct.
